Standard Terms & Conditions

- A signed Work Authorization with credit card information is required before any work commences. Work Authorization must be accompanied by a photo of the credit card and drivers license or government issued id.
- Each day that A and M Marine performs service for a customer, we will communicate photos, billable hours, and a description of work through text or email typically within one business day.
- All work is Invoiced as Time and Materials including travel time. Our current Labor rate and mileage rate is specified on Page 1 of this Work Authorization.
- A and M Marine advises owners of progress, billable time, and materials on a regular basis. Claims for adjustment must be made within 10 days of receipt of the Invoice.
- All invoices are sent via email, unless other arrangements have been made.
- An additional 2.5% County Environmental/Waste Disposal and Administration Fee is added to the invoice total.
- Parts are billed when ordered. Owners are responsible for manufacturer price increases prior to delivery. Labor is billed on a weekly basis or at our discretion.
- Terms are Cash, Wire Transfer, or Bank Check unless otherwise arranged in advance. Credit Card payments are subject to a service fee. We offer Zelle payments to avoid credit card and wire transfer fees for amounts under the current Zelle limit.
- Past due amounts will be charged in full to the credit card on file, plus a Credit Card service fee. Any amount past due over 15 days will be charged a monthly interest rate of 1.5% per month.
- All collection fees will be paid by the vessel owner. Legal disputes shall be filed in and settled through the State of South Carolina, County of Georgetown courts. The vessel owner is responsible for all legal fees. A&M shall recover the then current "Shop Rate" for filing and court time, mileage, and attorney fees.
- Due to the nature of marine repairs, A and M Marine does not provide "Estimates." Any approximation of cost or time is not considered an Estimate of final charges.
- A&M is not responsible for defective parts or incorrectly labeled parts from manufacturers, including, but not limited to, damage
 caused by defective or mislabeled parts. If a defective or mislabeled part is provided by the manufacturer and/or causes damage
 to the customer's equipment, A&M's liability is limited to providing documentation to the customer to allow them to file a claim
 with the manufacturer. A&M provides no warranty expressed or implied regarding parts' quality, appropriateness, or suitability for
 a particular purpose.
- A and M Marine LLC only warrants workmanship for 60 days from the date of completion. Parts carry the manufacturer's warranty (if any). Rebuilt or customer-supplied parts carry no warranty.
- All work must be checked after 10 hours of use to insure bolts, hose clamps, etc. have not loosed due to heating and cooling of
 components. Work validation must be performed by A and M Marine or another certified mechanic or dealer. If verification is
 performed by another dealer or mechanic, a detailed invoice is required for warranty claims. A and M Marine is not responsible
 for damage or warranty claims if verification is not performed.
- Manufacturer Warranty work must be pre-paid by the customer. A and M Marine will reimburse the customer when and if the manufacturer has reimbursed A and M Marine. Any fees for parts or labor not reimbursed by the manufacturer are the responsibility of the customer. A and M Marine will provide documentation to the customer regarding work performed and parts replaced, it is the responsibility of the customer to negotiate warranty coverage with the manufacturer.
- All warranty work must be performed in Georgetown, SC. Owner is responsible for all travel & dockage expenses. Regardless of any other consideration, maximum refund available is 12.5% of labor charges.
- The owner shall agree to have the vessel covered by a complete marine insurance package (hull coverage, indemnity, and liability coverage.) The owner agrees to release and discharge A and M Marine LLC and any of its subcontractors from any and all responsibility or liability for injury (including death), loss, or damage to persons or property in connection with the repair. This release and discharge shall cover without limitation any loss or damage resulting from employees, subcontractors, sea trails, part suppliers, fee, theft, fire, high/low water, wind, collision, ice, rain, or any other act of God. The vessel owner is responsible for the costs of and arranging for securing the vessel in the event of a Hurricane or other storm.
- Photos, videos, and descriptions of work performed are the property of A and M Marina and may be used for any media/marketing.
